Sara Steenrod, Research Development Specialists, Office for Research and Innovation, MSU

Sara Steenrod received her BA in Psychology from Carleton College, her Ph.D. in neuroscience from Columbia University, and then completed a postdoctoral fellowship at Rockefeller University. Dr. Steenrod is available to meet with investigators individually or in small groups to discuss funding opportunities, current grant projects, or grant editing. Dr. Steenrod has been assisting researchers with submissions to a number of agencies, while also developing expertise on MSU's ability to support the

Broader Impacts requirements for NSF proposals.



Lauren Aerni-Flessner, Research Development Specialists, Office for Research and Innovation, MSU

Lauren Aerni-Flessner, Ph.D. is a Research Development Specialist in the Office of Research & Innovation at Michigan State University. In this role, she helps faculty prepare competitive grant proposals to federal and foundation granting agencies through proposal editing, consultations, and pre-submission proposal reviews. She also organizes professional development seminars on grant-related topics for early career faculty. She holds a Ph.D. in molecular cell biology from Washington University in St. Louis and a master's degree in business administration from the

University of Michigan.

Domestic and Transnational Research: Challenges and Tips on Success 9:45 am – 10:40 am



Robin Lin Miller, Professor and Area Director, Doctoral Training, Ecological-Community Psychology, MSU

Dr. Robin Lin Miller is Professor of Psychology, director of doctoral training in ecological-community psychology, and associate director of training in program evaluation at Michigan State University. She served as lead evaluation specialist for Gay Men's Health Crisis in the early years of the HIV epidemic and established its first Department of Evaluation. She specializes in evaluating community-designed and led programs, including human rights interventions to promote access to HIV care and

reduce structural stigma. Her evaluations – principally conducted in the United States, Africa, and Caribbean – focus on adolescent and Black gay and bisexual men, bisexual girls, transgender women, and male sex workers. She served as lead scientist on the American Psychological Association's Task Force on Therapeutic Approaches to Sexual Orientation Distress, which is routinely cited in legislation banning conversion therapy practices. Awards include the 2023 Alva and Gunnar Myrdal Evaluation Practice Award from the American Evaluation Association for substantive cumulative contributions to the development of LGBTQ evaluation practice, and the 2022 Exemplary Project W. K. Kellogg Foundation Community Engagement Scholarship Award for evaluating human rights advocacy for LGBTQ people in Africa and the Caribbean. She is author of Breaking Barriers: Sexual and Gender Minority-led Advocacy to End AIDS in Africa and the Caribbean, published by Oxford University Press, co-authored with activist-scholar George Ayala. Past funders include AmFAR, the U.S. Centers for Disease Control and Prevention, National Institute of Mental Health, National Institute of Drug Abuse, and the Eunice Kennedy Shriver National Institute of Child Health and Development. She is currently supported by a grant from the U. S. Department of State's Bureau of Democracy, Human Rights, and Labor.



Estrella Torrez, Associate Professor and Co-Director – Indigenous Youth Empowerment Program, MSU

Estrella Torrez, PhD, is a community-based scholar of Latinx and Indigenous education. She is an Associate Professor at MSU's Residential College in the Arts and Humanities (RCAH) and a core faculty member in Chicano/Latino Studies and American Indian Indigenous Studies. Her research centers on equity and justice, particularly language politics and community-based knowledge among rural Latinx and urban Indigenous

communities. Her teaching focuses on community literacies, intergenerational community engagement, youth participatory action research, and language and culture.

Andrea Hunter, Professor and Chancellor's Fellow for Campus Climate, University of North Carolina at Greensboro

Andrea Hunter is a Professor in the Department of Human Development and Family Studies at UNC Greensboro and is the Chancellor's Fellow for Campus Climate. Her research focuses on the influences of race, gender, social class, and culture on family life, development, and individual wellbeing, primarily focusing on Black families. In her public scholarship, Dr. Hunter explores race, culture, and politics through the prism of identity, history, and memory. She is the writer and producer of the limited podcast series A Colored Girl Speaks: Meditations on Race and Other Magical Things. She has also served in various leadership roles to advance

equity, diversity, and inclusion in higher education.



Mathew J. Olovson, Director of Equity and Compliance, MSU

Matt Olovson is the Director of Equity and Compliance for the Michigan State University. In this role, he serves as the institution's Equal Opportunity/Affirmative Action Officer, responsible for administering programs and activities designed to ensure adherence to equal opportunity requirements of law and related university policies.
